

# QUICKBOOKS® DESKTOP FOR MAC

## UPDATING YOUR FARM CREDIT SERVICES OF AMERICA MY ACCOUNT ONLINE CONNECTION

---

Farm Credit Services of America (FCSAmerica) has updated to a new connection type to provide data to QuickBooks desktop. Going forward, you'll use a FCSAmerica-hosted sign-in form to authorize downloads. The process for adding accounts and downloading is the same, but the screen you use to sign in to FCSAmerica will look different.

For your security, FCSAmerica may periodically request that you reauthorize your accounts by signing in again. This may happen every 90 days or so.

This guide will help you update your online connection to ensure uninterrupted downloads of your FCSAmerica transactions.

### Before You Begin

Before updating your connection, make sure you have:

- The latest version of QuickBooks installed
- A reliable internet connection
- Your FCSAmerica My Account login credentials
- A backup of your QuickBooks company file

### Step 1: Prepare Your Company File

1. [Update QuickBooks to the latest release](#)
2. [Download transactions in online banking](#)
3. [Add/match them in QuickBooks](#)
4. [Create a backup of your company file](#)

### Step 2: Turn Off Online Banking Services

1. Close the Downloaded Transactions window.
2. Go to **Lists > Chart of Accounts**.
3. Highlight the account and select the pencil icon to edit.
4. Select **Online Settings**.
5. Under **Download Transactions**, select **Not enabled**.
6. Select **OK** to confirm, then select **OK** again.

### Step 3: Set Up Online Banking Services

1. Make sure the primary account owner is signed in with their Intuit account.
2. Go to **QuickBooks > Settings** and click **Intuit Account Sign In**.
3. Complete the setup wizard: **Banking > Online Banking Setup**.

4. Search for **Farm Credit Services of America**, select it, and click **Next**.
5. Follow prompts to log in with either your Intuit account or FCSAmerica My Account credentials.
6. Once connected, map your FCSAmerica accounts to the corresponding QuickBooks accounts.

#### **Step 4: Download Transactions**

1. Select **Banking > Downloaded Transactions**.
2. From QuickBooks Account, select the account you wish to download.
3. Select **Download**.

Note: You may need to review and categorize the previous day's transactions.

#### **Troubleshooting & Tips**

- If login fails, verify your FCSAmerica My Account credentials and try again.
- Ensure you are logged into QuickBooks as the primary account owner.
- Make sure your product is updated to the latest release before reconnecting.
- After reconnecting, review account mappings to ensure transactions post to the correct accounts.

#### **You're All Set!**

Once you've completed these steps, your QuickBooks software will now be connected using the new connection. This new method ensures more secure, reliable, and faster updates for your accounts.
